

Updates to Your Wellcare Prime by Absolute Total Care (Medicare-Medicaid Plan) covered benefits

Wellcare Prime by Absolute Total Care (Medicare-Medicaid Plan) wants you to know about a change to the copays for services and items covered by Healthy Connections Medicaid. Effective July 1, 2024 all copays for services or supplies covered by Healthy Connections Medicaid will be removed for services received on or after July 1, 2024. Please see the chart below for more information.
